#### A Message from the Executive Director, William "Bill" Kahl

HNCO has faced another year of challenges again...primarily due to COVID-19 continuing through 2021.

Our staff has dealt with the challenges faced by every health care provider in dealing with this epidemic, perhaps compounded further by the particularly vulnerable patient population we serve. Our census has continued to lag as our referral sources



experience the same challenges associated with COVID-19. Yet, through it all, our team has maintained our high-quality standards and provide the best hospice service in the communities we serve (and we can still prove it by referring to: medicare.gov/hospicecompare)

Another major challenge has been the ongoing and growing shortage in nursing and home care aide personnel across the healthcare industry. Compensation has been rising rapidly as the industry competes for these essential members of every care team. Add to that the ever-increasing inflation numbers and 2021 proved every bit as challenging as 2020.

Yet, despite these challenges we have finished the year with our fourth consecutive positive margin and increase to our endowment funds. We still have not laid anyone off during the pandemic, nor reduced anyone's pay. In fact, our Board approved using our entire margin for our staff, it was devoted entirely to market adjustments and bonuses for our team!

Additionally, we are still able to fund our service differentiators, those patient and community services that continue to set us apart from our for-profit competitors. Services like, our kid's grief camp, free bereavement services open to the public, grief counseling for schools in our community, our nurse practitioner driven Palliative Care program, our virtual reality therapy, and our patient assistance fund that covers costs and items not included by insurance or Medicare. Any profit or margin we generate is ploughed back into our team and programs instead of going to dividends or profits. Yet the for-profit sector of Hospice continues to grow nationally.

HNCO will continue to prepare for the future, a future including a rapidly changing Medicare program, increased competition, and keeping up with communication and technological demands of the evolving healthcare industry. We could not do any of this without our wonderful team of caregivers and the generous support of the communities we serve, so thanks once again to everyone who helps make the mission of HNCO possible!

#### Electric Cooperative People Funds Continue to Provide Grants to HNCO

\$6,353.47 from the Lorain-Medina Rural Electric Cooperative People Fund for new medical training equipment. The equipment will help preform annual education for hospice and palliative care nurses.

Life's Seasons Palliative Care program, established in 2015, improves the quality of lives of hundreds of patients annually who have chronic diseases by controlling symptoms, pain, and stress.

Certified nurse practitioners partner with the patients primary care physicians to extend care into his or her home or care facility.

Palliative care differs from hospice care in that it may be provided for anyone with a serious illness, at any age and at any stage of illness. One can receive palliative care along with curative treatment, therefore it is not dependent on prognosis.


#### Russell & Mary Gimbel Foundation Grant Helps Fulfill Patients' Special Requests

### Consider Making Qualified Charitable Distributions (QCDs) to HNCO

With passage of the Protecting Americans from Tax Hikes (PATH) Act of 2015, the QCD provision is now a permanent part of the Internal Revenue Code.

If you are age 72 or older, IRS rules require you to take a minimum distribution (RMD) each year from your tax-deferred retirement accounts.

A QCD is a direct transfer of funds from your IRA payable directly to a qualified 501(c)(3) charity like HNCO. These QCD amounts distributed to charities can be counted towards satisfying your RMD for the year. You may distribute up to \$100,000 and the QMD is excluded from your taxable income.

Consult with your tax advisor to determine whether your IRA qualifies for QMDs.
