

A Message from the Executive Director, William "Bill" Kahl

We are well into the new year, and we have much to be thankful for. The COVID crises continues to subside, and we recently joined the growing chorus of healthcare providers that have ended their masking and social distancing safeguards. As we deal with the most compromised patients, we waited for the area hospitals to phase these protocols out before joining. Our HNCO team continues to provide the highest quality care for its patients and will always err on the side of caution when it comes to safety, in fact we will continue to follow the protocols at extended care facilities that still demand these precautions.



Yet, C19 aftereffects still linger, in that our census has yet to recover to pre-pandemic levels. Last year was the first in many that we did not have a positive operating margin. HNCO continues to provide the very best care in the area and ranks among the top tier of hospice providers. We are looking to expand our territory into adjacent counties and are working with the Care Solutions Network to solicit contracts in the ever-increasing inclusion of hospice services in managed care, in fact we just secured our first contract with Aetna in Ohio. Despite increasing competition from the for-profit sector, HNCO continues to offer services that you will not find them providing. Our bereavement services are open to the public, not just for our patients' families, we even provide them to almost two dozen schools in our area. We also provide a children's grief camp, Camp Hope, and did so last year while still coping with the pandemic. We offer Virtual Reality experience for our patients, the second in the country to do so, and maintain a patient fund to augment services and requests that Medicare and insurance will not cover.

We also provide a robust palliative care program for pre-hospice patients. However, as the challenge of C19 wanes, we find ourselves coping with a new one, in the ever-increasing shortage of nurses and home care aides. Retention and attraction of these essential healthcare workers is a huge problem in all healthcare and will continue for the foreseeable future. Yet, we are still blessed with a strong team and the most generous community support I have ever witnessed. This support is what makes these "extra" services possible! We are committed to making HNCO a great place to work and our team is looking forward to meeting these challenges and continuing to provide the best hospice care in the area to our patients and their families.

Certified nurse practitioners partner with the patient's primary care physicians to extend care into his or her home or care facility.

Palliative care differs from hospice care in that it may be provided for anyone with a serious illness, at any age and at any stage of illness. One can receive palliative care along with curative treatment, therefore it is not dependent on prognosis.





Consider Making Qualified Charitable Distributions (QCDs) to HNCO

With passage of the Protecting Americans from Tax Hikes (PATH) Act of 2015, the QCD provision is now a permanent part of the Internal Revenue Code.

If you are age 72 or older, IRS rules require you to take a minimum distribution (RMD) each year from your tax-deferred retirement accounts.

A QCD is a direct transfer of funds from your IRA payable directly to a qualified 501(c)(3) charity like HNCO. These QCD amounts distributed to charities can be counted towards satisfying your RMD for the year. You may distribute up to \$100,000 and the QMD is excluded from your taxable income.

Consult with your tax advisor to determine whether your IRA qualifies for QMDs.
